Role Summary

The Sainsbury Laboratory is a £62.5m building, which will house 120 researchers and 30 support staff. It is highly serviced with a large amount of complex plant and research equipment including cutting-edge technology.

The role holder will be a member of Dr James Locke's research group at the Sainsbury Laboratory, to assist postdoctoral researchers in the field of systems biology. The role holder will be involved in research, have a key role in the lab organisation and management, provide continuity in technical expertise and resources, and also be instrumental in the training of new or junior researchers involved in analysis of microscopy data using in-house Matlab code.

The role holder will participate in the overall contribution of the Institute, as appropriate.
